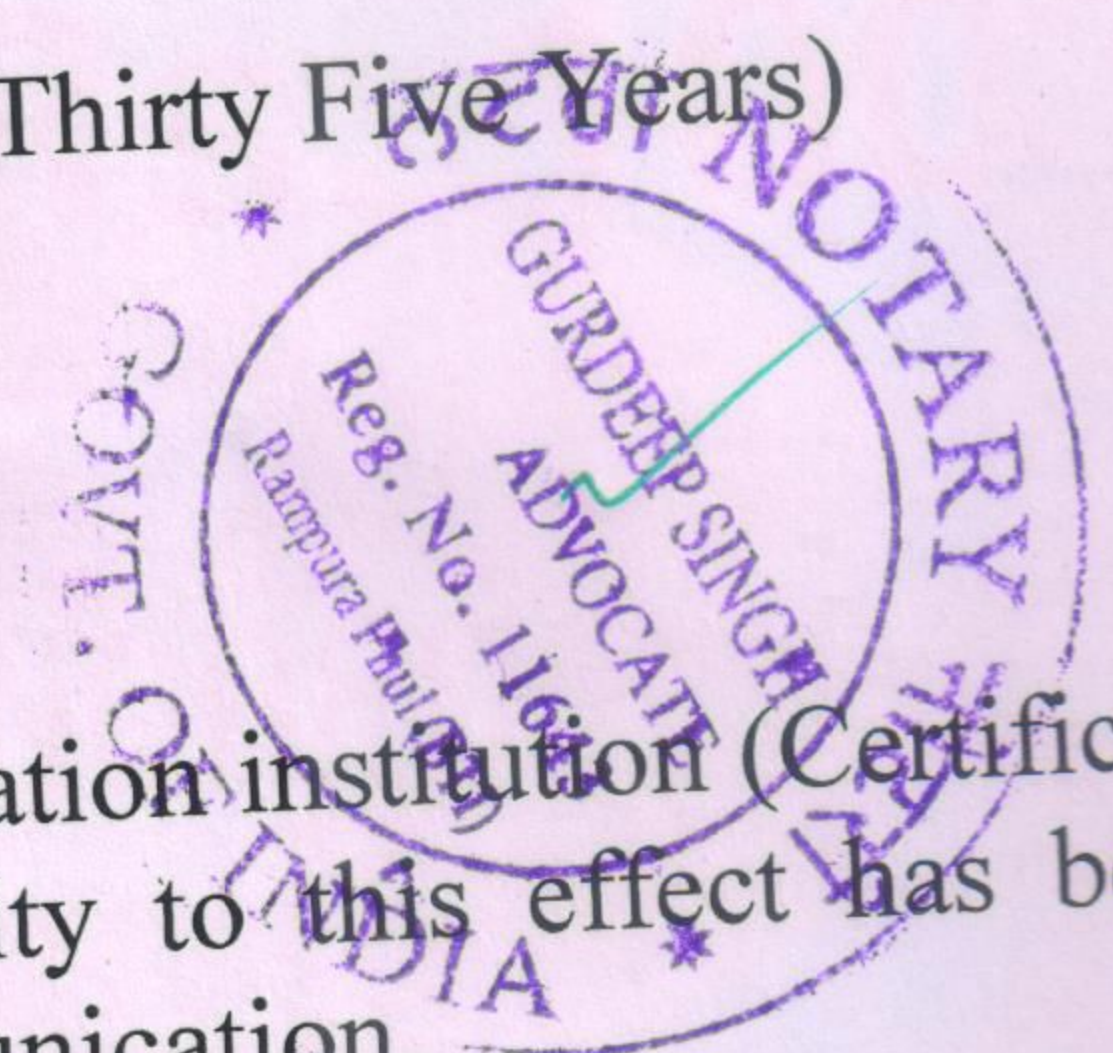

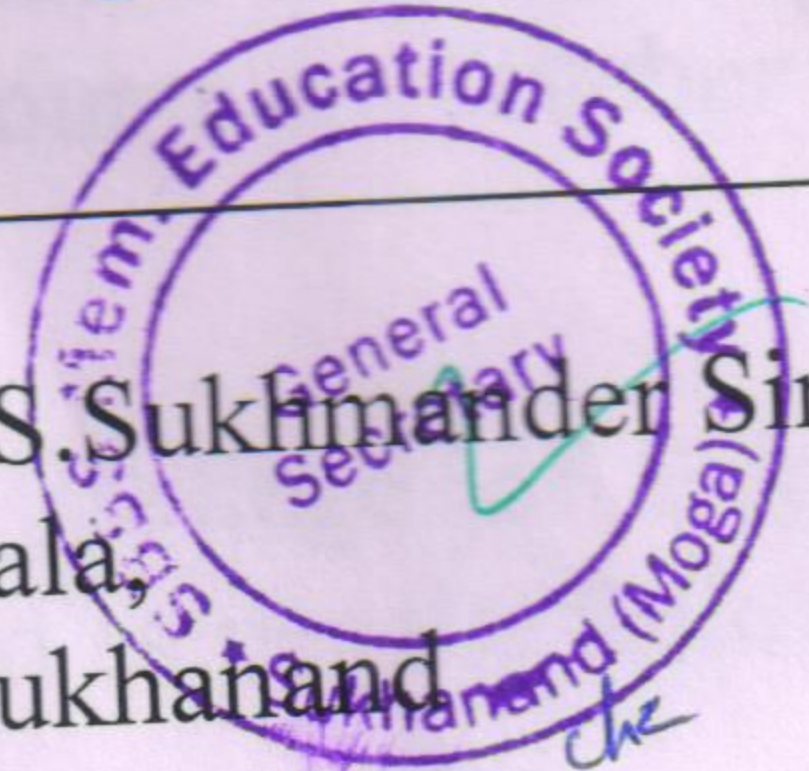
3. That the land is on lease basis for a period of 35 years (Thirty Five Years)
